The evaluation assessed the department's fire suppression, emergency medical response, communications systems, water supply, and prevention programs, confirming best-in-class performance across all categories.

"This ISO Class 2 designation is more than a number, it's a reflection of the professionalism, accountability, dedication, and teamwork of every firefighter, paramedic, and support member in our department," said **Fire Chief Michael Contreras**.
